- Annual General Meeting
 - 41st International Congress on Intellectual Property took place. It counted on Brazil Minister of Economy, Mr. Paulo Guedes, and over 1.100 registered participants.
 - The Congress has generated spontaneous media attention, with almost 40 different media channels citing the event over 90 times.
 - The event has resulted in over 15,000 views in social media, 5,400 sessions and over 3,100 single users.

ABPI - Promoting Changes to IP Environment in Brazil

In 2021, ABPI launched a Class Action seeking the Government to recognize the Financial Autonomy of INPI (Brazilian Industrial Property Institute), relying on the Supreme Court decision on the Patent Protection Term Extension case, which acknowledged that the reason for the delay in patent granting was largely due to the disinvestment at the INPI, despite this entity's generating a very high superplus.



ABPI in the media

- ABPI has been cited 250 times in 93 differing media vehicles, including 171 citations specifically citing ABPI's Congress
- 13 podcasts produced, with over 4,500 views.
- ABPI YouTube channel had over 2,500 exhibition hours, with over 8,000 views.
